- (iii) seek the assistance from the Member for Tamworth, as required, to retain the existing grant, as per (ii) above and provide additional funding for the construction of the Organics Recycling Facility (ORF);
- (iv) negotiate with Cleanaway, as required, any changes to services provided under the current Waste Collection Services contract which assumed the Organics Recycling Facility would be operational as of 1 July 2022, now that the facility will not be operational on that date;
- (v) prepare a detailed design of the Organics Recycling Facility and if necessary, seek a modification to the existing development consent seeking approval for any modifications;
- (vi) prepare new Tender documents for the construction of the Organics Recycling Facility based on the detailed design; and
- (vii) provide \$250,000 from the Waste Reserve to fund the agreed work.
