***RECOMMENDATION***

***That Council:-***

- (i) consider the issues raised at the Community Consultation Forums together with the information supplied in any additional correspondence/documentation in conjunction with the Business Paper for the Extraordinary Council meeting on 7 June 2010;***
- (ii) rectify the anomaly identified in this Addendum by altering the recommendation in the Business Paper relating to Late Correspondence No 5 under Rural RU4/Clause 3 to state “Retain Intensive Livestock Agriculture as a prohibited use in the RU4 zone”.***

**SUMMARY**

The purpose of this Addendum is to provide a summary of the representations made to Councillors at the Community Consultation Forums on 28 and 29 May 2010. The Addendum also contains a copy of any items of late correspondence received since the release of the Business Paper on 21 May 2010. The recommendations made in the Business Paper on 21 May 2010 remain unchanged with the exception of item (ii) in the Recommendation above.

**BACKGROUND**

The Business Paper for the Draft TRLEP 2009 was publicly released on 21 May 2010. This Report indicated that any additional information presented to Councillors at the Community Consultation Forums would be recorded and collated into an “Addendum” to the Business Paper for consideration at the Extraordinary Meeting of Council scheduled for 7 June 2010.

**COMMENTARY**

Two Community Consultation Forums were held on 28 and 29 June 2010 respectively. A total of 34 presentations were made to Councillors at these Forums. A report containing a summary of these presentations is shown in **ANNEXURE 1** to this Addendum.

The majority of the presentations either re-emphasised the points raised in the original submissions or supplied additional information in response to the recommendation/s contained within the Business Paper.

Further, some community members and government officers who were unable to attend either of the Forums have provided additional documentation and verbal advice for Council's consideration.

Copies of any additional documentation provided at the Forums, together with additional items of late correspondence received since 21 May 2010, are provided in **CONFIDENTIAL ENCLOSURE 1** to this Addendum.

The NSW Department of Industry and Investment has verbally advised that there is an anomaly in the Business Paper Recommendation for the RU4 zone which states "*Retain Agriculture as a prohibited use in the R4 zone*". Instead, this recommendation should read "*Retain Intensive Livestock Agriculture as a prohibited use in the RU4 zone*". This proposed amendment is supported.

## **CONCLUSION**

It is recommended that this Addendum be considered in conjunction with the Business Paper at the Extraordinary Meeting on 7 June 2010 and that the Council amend the Draft TRLEP 2009 in accordance with the recommendations outlined in the Business Paper and recommendation (ii) in this Addendum.
