Installation of ceiling fans in rooms/areas that do not have evaporative cooling are not covered under the water saving rebates scheme.</li> <li>Properties with reverse cycle air conditioning are not eligible for the rebate as this is an initiative to reduce water consumption from evaporative coolers</li> <li>Must be completed and signed off by a licensed electrical contractor</li> <li>Can claim multiple units</li> <li>Item eligible for rebate if purchased on or after 18 December 2019</li> </ul>	50% or up to \$50ea
<p><b>Greywater Diversion System (GDS) - Description and T&amp;C's</b></p> <ul style="list-style-type: none"> <li>A GDS diverts used water from showers, bath, basins and laundries. Greywater can be used for subsurface dripper system and the water is not or must not be stored</li> <li>The GDS is required to be an approved WaterMark system as a whole. You cannot build your own system using individual certified WaterMark components</li> <li>Installation must be completed and signed off by a licenced plumber</li> <li>Item eligible for rebate if purchased on or after 18 December 2019</li> <li>For more information on GDS please refer to Council's <i>Recycling Greywater Fact Sheet</i></li> </ul>	50% or up to \$150
<p><b>Greywater Treatment System (GTS) - Description and T&amp;C's</b></p> <ul style="list-style-type: none"> <li>A GTS diverts used water from showers, bath, basin and laundries and it is treated by a controlled natural process to purify the wastewater suitable for reuse. It can be used for toilet flushing, washing machine or surface irrigation.</li> <li>Installation must be completed and signed off by a licenced plumber</li> <li>Applicant must provide a copy of the written confirmation or a permit approval from Council for either an approved system or an exempt system with the rebate application form</li> <li>Item eligible for rebate if purchased on or after 18 December 2019</li> <li>For more information on GTS please refer to Council's <i>Recycling Greywater Fact Sheet</i></li> </ul>	50% or up to \$800
<p><b>Hot Water System Diverter (Return) - Description and T&amp;C's</b></p> <ul style="list-style-type: none"> <li>System that automatically diverts the cooled hot water in a property's hot water pipes when not in use and sends it back into the cold water line, rainwater tank, or other storage tank, instead of otherwise flowing down the drain</li> <li>The system is required to be a Smart Approved WaterMark system for the rebate</li> <li>Installation must be completed and signed off by a licenced plumber</li> <li>Can claim multiple</li> <li>Item eligible for rebate if purchased on or after 18 December 2019</li> </ul>	50% or up to \$50ea
<p><b>Plumbers Audit - Description and T&amp;C's</b></p> <ul style="list-style-type: none"> <li>A property water efficiency audit must be completed and signed off by a licenced plumber</li> <li>The Waterwise Plumber's Audit Checklist and plumbers invoice must be attached to the rebate application - Ask plumber to provide you with a copy</li> </ul>	50% or up to \$100

<p><b>Commercial Steam Cleaner - Description and T&amp;C's</b></p> <ul style="list-style-type: none"> <li>• Steam cleaning systems using steam rather than water flow to clean surfaces. There are various models that can be applied in the health, contract cleaning, automotive, industrial, animal care and education industries.</li> <li>• Must be a Smart Approved WaterMark system for the rebate</li> <li>• Item eligible for rebate if purchased on or after 18 December 2019</li> </ul>	50% or up to \$200
<p><b>Commercial Chemical Cleaner - Description and T&amp;C's</b></p> <ul style="list-style-type: none"> <li>• Replaces steam cleaning and uses less water. ### Applicants Declaration

#### **Terms and Conditions (T&C's)**

In applying for Tamworth Regional Council's Water Saving Rebates, I accept the following terms and conditions and understand that:

1. My property must be connected to a Tamworth Regional Council town water supply;
2. The products I am claiming, on must be new and have the correct WELS, Smart Approved Watermark, or Australian Standards rating;
3. If I am living in, or moving into a new home, or a home having recent renovations/additions valued over \$50k, I can only claim a one-off rebate payment for additional volume of rainwater tanks, over-and-above Building Sustainability Index (BASIX) requirements. I cannot claim on multiple tanks. I cannot claim showerheads or toilets required by BASIX. I cannot claim a pool cover required by BASIX on pools of 40-kilolitre capacity or above;
4. For any water saving products or services I am claiming, I have provided clearly-readable copies of receipts as proof of purchase, and I understand these copies will be kept by Council
5. I confirm that any products being claimed, have been installed by either a licensed plumber and must comply with the NSW Code of Practice (Plumbing and Drainage), a licensed electrical contractor and must comply with AS3000 or a qualified pool technician for the relevant items as outlined in the rebate advice;
6. I have attached any required trades person declarations as required for any of the products I am claiming a rebate on;
7. I agree that Tamworth Regional Council reserves the right to conduct approval inspections of any water saving products subject to the application for a rebate;
8. I agree that all water saving products which have attracted a Council rebate are to remain at the property where they have been installed as per the rebate application form;
9. I understand that each application for the property, will be assessed on an individual basis to ensure a reasonable outcome for the resident and Council as public funding body and reserves the right to reject applications on a case by case basis;
10. I understand that the amount of the rebate will be calculated, but only up to, using the amounts indicated in the rebate advice for each item;
11. I acknowledge that payments or credit will be made to my nominated preference option, based on the value of the overall rebate for the application after the application has been assessed and approved by Council;
12. I acknowledge that Tamworth Regional Council accepts no responsibility in respect of any claim, cause or action, loss or damage arising from, or in relation to the installation of any product.
13. I understand and acknowledge that rebates on new items are only eligible from Wednesday 18 December 2019 and 11 February 2020 following the Council decision to include those items and that items before this date are ineligible for the rebate.
