- 12.4 The issue of cars parking on the grass was discussed; it was discussed with Lisa that we would like to install some bollards to block off access. It was decided that this could be a committee project. The committee voted on the proposal to install bollards to block access, and this was passed unanimously.
- 12.5 Lisa raised the issue of hire fees. We must set the fees in advance and cannot leave them as subjective. It was decided that Tom would contact Loombera Hall to find out how they work it
- 12.6 It was discussed that the Bush Cricket Association currently does not contribute to the cost of the grounds. It was noted that they were using electricity, which they should contribute towards. There was a motion put forward that Tom and Emma get in touch with the Bush Cricket Chairman and discuss what they would be willing to contribute. There was a suggestion of \$1000 per year to be reviewed each AGM.
