Information about this licence

Dictionary

A definition of terms used in the licence can be found in the dictionary at the end of this licence.

Responsibilities of licensee

Separate to the requirements of this licence, general obligations of licensees are set out in the Protection of the Environment Operations Act 1997 ("the Act") and the Regulations made under the Act. These include obligations to:

- ensure persons associated with you comply with this licence, as set out in section 64 of the Act;
- control the pollution of waters and the pollution of air (see for example sections 120 132 of the Act);
- report incidents causing or threatening material environmental harm to the environment, as set out in Part 5.7 of the Act.

Variation of licence conditions

The licence holder can apply to vary the conditions of this licence. An application form for this purpose is available from the EPA.

The EPA may also vary the conditions of the licence at any time by written notice without an application being made.

Where a licence has been granted in relation to development which was assessed under the Environmental Planning and Assessment Act 1979 in accordance with the procedures applying to integrated development, the EPA may not impose conditions which are inconsistent with the development consent conditions until the licence is first reviewed under Part 3.6 of the Act.

Duration of licence

This licence will remain in force until the licence is surrendered by the licence holder or until it is suspended or revoked by the EPA or the Minister. A licence may only be surrendered with the written approval of the EPA.

Licence review

The Act requires that the EPA review your licence at least every 5 years after the issue of the licence, as set out in Part 3.6 and Schedule 5 of the Act. You will receive advance notice of the licence review.

Fees and annual return to be sent to the EPA

For each licence fee period you must pay:

- an administrative fee; and
- a load-based fee (if applicable).

The EPA publication "A Guide to Licensing" contains information about how to calculate your licence fees. The licence requires that an Annual Return, comprising a Statement of Compliance and a summary of any monitoring required by the licence (including the recording of complaints), be submitted to the EPA. The Annual Return must be submitted within 60 days after the end of each reporting period. See condition R1 regarding the Annual Return reporting requirements.

Usually the licence fee period is the same as the reporting period.

Transfer of licence

The licence holder can apply to transfer the licence to another person. An application form for this purpose is available from the EPA.

Public register and access to monitoring data

Part 9.5 of the Act requires the EPA to keep a public register of details and decisions of the EPA in relation to, for example:

- licence applications;
- licence conditions and variations;
- statements of compliance;
- load based licensing information; and
- load reduction agreements.

Under s320 of the Act application can be made to the EPA for access to monitoring data which has been submitted to the EPA by licensees.

1 Administrative Conditions

A1 What the licence authorises and regulates

A1.1 This licence authorises the carrying out of the scheduled activities listed below at the premises specified in A2. The activities are listed according to their scheduled activity classification, fee-based activity classification and the scale of the operation.

Unless otherwise further restricted by a condition of this licence, the scale at which the activity is carried out must not exceed the maximum scale specified in this condition.

A1.3 This licence is to be construed in a manner that will promote the objectives referred to in the condition above.



3 Limit Conditions

L1 Pollution of waters

- L1.1 Except as may be expressly provided in any other condition of this licence, the licensee must comply with section 120 of the Protection of the Environment Operations Act 1997.
- L1.2 The licensee may only discharge untreated or partially treated sewage from the sewage treatment plant and/or the reticulation system subject to the conditions of this licence, including Sections O1 and O2.

L2 Load limits

- L2.1 The actual load of an assessable pollutant discharged from the premises during the reporting period must not exceed the load limit specified for the assessable pollutant in the table below.
- Note: An assessable pollutant is a pollutant which affects the licence fee payable for the licence.
- L2.2 The actual load of an assessable pollutant must be calculated in accordance with the relevant load calculation protocol.

- L3.5 When a wet weather bypass as defined in condition L4.1 has occurred, exceedances of the concentration limits in condition L3.4 are permitted at the following points, where the bypass was the sole cause of the exceedance: Point 20
- L3.6 The licensee is not taken to have exceeded a quality limit specified in this licence for Biochemical Oxygen Demand, pH or Total Suspended Solids at Point 20, if:

(a) monitoring by the licensee shows that the level of chlorophyll-a in the final maturation pond at the Westdale Plant during any exceedance was 100 ug/L or greater (demonstrating that the exceedance was caused by excessive algal growth).

L4 Volume and mass limits

L4.1 For the points identified below, no discharge to waters is permitted unless the specified volume of runoff or flow is exceeded or the following conditions are met.

Runoff that collects in the runoff control ponds as a result of events other than rainfall may not be discharged from the premises.

Note: For the purposes of this condition, the licensee must maintain daily inspection records in order to demonstrate that each runoff control pond was empty prior to a rainfall runoff event.

L5 Waste

L5.1 The licensee must not cause, permit or allow any waste generated outside the premises to be received at the

premises for storage, treatment, processing, reprocessing or disposal or any waste generated at the premises to be disposed of at the premises, except as expressly permitted by the licence.

- L5.2 This condition only applies to the storage, treatment, processing, reprocessing or disposal of waste at the premises if those activities require an environment protection licence.
- L5.3 The licensee may receive sewage and sewage sludge and residues (K130) and grease trap waste (K110) generated outside the premises for treatment, processing or reprocessing at the premises. The licensee must take reasonable steps to ensure that sewage and sewage sludge and residues (K130) and grease trap waste (K110) received at the premises has been lawfully discharged in accordance with a trade waste agreement or customer contract (as applicable) in force between the licensee and the generator of waste. The licensee must treat, process or reprocess the sewage and sewage sludge and residues (K130) and grease trap waste (K110) in accordance with this licence prior to discharge from this premises.
- L5.4 The licensee may receive, store, treat, process or reprocess and/or transfer at the premises sewage products and sewage sludge and residues (K130) and grease trap waste (K110) generated or stored outside the premises by the licensee's other sewage treatment systems. Sewage products sewage sludge and residues (K130) and grease trap waste (K110) must be received, treated, processed or reprocessed in accordance with this licence.
- L5.5 Receival, storage and treatment of grease trap waste (K110) at the premises is permitted to be carried out on an ongoing permanent basis.

L6 Noise limits

L6.1 Noise generated at the premises must not exceed the noise limits in the table below.

L6.2 For the purpose of the table above:

a) Day is defined as the period from 7am to 6pm Monday to Saturday and 8am to 6pm Sundays and Public Holidays;

b) Evening is defined as the period from 6pm to 10pm;

c) Night is defined as the period from 10pm to 7am Monday to Saturday and 10pm to 8am Sundays and Public Holidays.

L6.3 The noise limits identified in the above table do not apply at privately owned residences that are subject to a private agreement, relating to the noise levels, between the licensee and the land owner.

L6.4 Determining Compliance

To determine compliance:

a) with the LAeq(15 minute) noise limits in the Noise Limits table, the noise measurement equipment must be located:

i) approximately on the property boundary, where any dwelling is situated 30 metres or less from the property

boundary closest to the premises; or

ii) within 30 metres of a dwelling façade, but not closer than 3m, where any dwelling on the property is situated more than 30 metres from the property boundary closest to the premises; or, where applicable

iii) within approximately 50 metres of the boundary of a National Park or a Nature Reserve.

b) with the LA1(1 minute) noise limits in the Noise Limits table, the noise measurement equipment must be located within 1 metre of a dwelling façade.

c) with the noise limits in the Noise Limits table, the noise measurement equipment must be located:

i) at the most affected point at a location where there is no dwelling at the location; or

- ii) at the most affected point within an area at a location prescribed by part (a) or part (b) of this condition.
- L6.5 The noise limits set out in the Noise Limits table apply under all meteorological conditions except for the following:

a) Wind speeds greater than 3 metres/second at 10 metres above ground level; or

b) Stability category F temperature inversion conditions and wind speeds greater than 2 metres/second at 10 metres above ground level; or

c) Stability category G temperature inversion conditions.

For the purposes of this condition:

a) Data recorded by the meteorological station identified as EPA Identification Point(s) 44 must be used to determine meteorological conditions; and

b) Temperature inversion conditions (stability category) are to be determined by the sigma-theta method referred to in Part E4 of Appendix E to the NSW Industrial Noise Policy.

L6.6 For the purposes of determining the noise generated at the premises the modification factors in Section 4 of the NSW Industrial Noise Policy must be applied, as appropriate, to the noise levels measured by the noise monitoring equipment.

L7 Hours of operation

- L7.1 All construction work at the premises must only be conducted between 7 am to 6 pm Monday to Friday, excluding public holidays.
- L7.2 Operational activities at the premises, other than sewerage reticulation, sewage treatment processes and irrigation of effluent, may only be carried on between 7 am to 6 pm Mondays to Fridays, excluding public holidays.
- L7.3 This condition does not apply to the delivery of material outside the hours of operation permitted by condition L7.1 or L7.2, if that delivery is required by police or other authorities for safety reasons; and/or the operation or personnel or equipment are endangered. In such circumstances, prior notification must be provided to the EPA and affected residents as soon as possible or within a reasonable period in the case of emergency.
- L7.4 The hours of operation specified in conditions L7.1 and L7.2 may be varied with written consent if the EPA is satisfied that the amenity of the residents in the locality will not be adversely affected.

L8 Potentially offensive odour

L8.1 No condition in this licence identifies a potentially offensive odour for the purposes of section 129 of the

Protection of the Environment Operations Act 1997.

Note: Section 129 of the Protection of the Environment Operations Act 1997 provides that the licensee must not cause or permit the emission of any offensive odour from the premises but provides a defence if the emission is identified in the relevant environment protection licence as a potentially offensive odour and the odour was emitted in accordance with the conditions of a licence directed at minimising odour.

4 Operating Conditions

O1 Activities must be carried out in a competent manner

O1.1 Licensed activities must be carried out in a competent manner. This includes:

a) the processing, handling, movement and storage of materials and substances used to carry out the activity; and

b) the treatment, storage, processing, reprocessing, transport and disposal of waste generated by the activity.

- Note: The requirements of O1.1 apply to the whole of the premises, including the reticulation system.
- O1.2 Biosolids at the premises must be stored, treated, processed, classified, transported and disposed in accordance with the Biosolids Guidelines, or as otherwise approved in writing by the EPA.
- Note: This condition does not apply to the reuse or disposal of biosolids by the licensee at locations other than the premises.

O2 Maintenance of plant and equipment

- O2.1 All plant and equipment installed at the premises or used in connection with the licensed activity:a) must be maintained in a proper and efficient condition; andb) must be operated in a proper and efficient manner.
- Note: The requirements of O2.1 apply to the whole of the premises, including the reticulation system.
- O2.2 For the purposes of this condition, "plant and equipment" includes drainage systems, infrastructure, pollution control equipment and fuel burning equipment, but does not refer to equipment which has been decommissioned but is still on site.

O3 Dust

O3.1 The premises must be maintained in a condition which minimises or prevents the emission of dust from the premises.

O4 Effluent application to land

O4.1 The quantity of effluent applied to the utilisation area(s) must not exceed the capacity of the utilisation area(s) to effectively utilise the effluent.

For the purpose of this condition, "effectively utilise" includes the use of the effluent for pasture or crop production, as well as the ability of the soil to absorb the nutrient, salt, hydraulic loads and the applied organic material without causing harm to the environment. Monitoring of land and receiving waters to determine the impact of waste water application may be required by the EPA.

- O4.2 Effluent application to the utilisation area(s) must not occur in a manner that causes surface run-off from the utilisation area(s).
- O4.3 Spray from effluent application to the utilisation area(s) must not drift beyond the boundary of the utilisation area(s) to which it has been applied.
- O4.4 All effluent application operations and activities occurring at the premises must be carried out in a manner that will minimise dust at the boundary of the utilisation area.
- O4.5 Effluent liquid waste pipelines and fittings must be clearly identified. Standard watertaps, hoses and valves must not be fitted to the pipelines of the effluent system. The effluent system must not be connected to other pipelines. Lockable valves or removable handles must be used where there is public access to the effluent.
- O4.6 Public access to any effluent utilisation area must be denied during effluent application and until the effluent application area has dried.
- O4.7 Adequate notices, warning the public not to drink or otherwise use the treated effluent, must be erected on the site. These notices must be legible English and in any other languages as may be necessary, and must indicate at least that the water in use is "Reclaimed Water Unfit for Drinking".
- O4.8 The licensee must retain the utilisation area.
- O4.9 At least 14 days prior to a utilisation area being offered for sale, being disposed of or otherwise rendered unavailable for use, the EPA must be advised in writing of this intention.
- O4.10 Livestock access to any effluent application area(s) must be denied during effluent application and until the applied effluent area(s) has dried.
- O4.11 Pasture or fodder crops must not be harvested before the effluent utilisation area(s) has dried.

O5 Emergency response

O5.1 In the event of an overflow or bypass that harms or is likely to harm the environment, the licensee must use all practicable measures to minimise the impact of the overflow or bypass on the environment and public health. These measures are to be implemented as soon as practical after the licensee or one of the licensee's employees or agents becomes aware of the overflow or bypass.

O6 Processes and management

O6.1 Sewage or effluent discharged must not be discharged from Point(s) 20 unless it has been treated in

accordance with this condition.

O6.2 Sewage or effluent must be treated in accordance with the following requirements:

(a) The proportion of inflows to the sewage treatment plant less than 4.6 times Average Dry Weather Flow (ADWF) must receive screening, degritting, either trickle filtration or extended aeration treatment, and final disinfection ponding prior to discharge from point 20;

(b) The proportion of inflows to the sewage treatment plant greater than 4.6 times ADWF must receive screening and degritting prior to discharge from point 20; and

(c) The proportion of inflows to the sewage treatment plant discharged as precautionary releases from storage/disinfection ponds in accordance with condition L4.1 must receive screening, degritting, either trickle filtration or extended aeration treatment, and final disinfection ponding prior to discharge from point 20.

- O6.3 The licensee must ensure that any extensions to the reticulation system after January 2004 are planned, designed, constructed and installed to prevent as far as practicable overflows from the premises.
- Note: "The premises" includes both the new and the previously existing parts of the sewage treatment system.
- O6.4 The licensee must maintain a minimum freeboard of 0.7 metres in the effluent reuse farm storage dam shown on the map titled "Drawing 05 Drainage" dated 30 March 2010 on file LIC07/2325-06 (DOC15/276083) at all times, except during heavy rainfall.

O7 Other operating conditions

O7.1 The licensee must not enter into any trade waste agreement to discharge organophosphate pesticides (including chlorpyrifos, diazinon, malathion) into the sewerage system.

O7.2 Prohibition on acceptance of pesticides

The licensee must not consent to any discharge of organochlorine pesticides (such as dieldrin, heptachlor and chlordane) into the sewerage system.

O7.3 New sewage pumping stations

Dry weather overflows resulting in pollution of waters from any sewage pumping station(s) installed within the sewage treatment system after January 2004 are not permitted.

5 Monitoring and Recording Conditions

M1 Monitoring records

- M1.1 The results of any monitoring required to be conducted by this licence or a load calculation protocol must be recorded and retained as set out in this condition.
- M1.2 All records required to be kept by this licence must be:

- a) in a legible form, or in a form that can readily be reduced to a legible form;
- b) kept for at least 4 years after the monitoring or event to which they relate took place; and
- c) produced in a legible form to any authorised officer of the EPA who asks to see them.
- M1.3 The following records must be kept in respect of any samples required to be collected for the purposes of this licence:
 - a) the date(s) on which the sample was taken;
 - b) the time(s) at which the sample was collected;
 - c) the point at which the sample was taken; and
 - d) the name of the person who collected the sample.

M2 Requirement to monitor concentration of pollutants discharged

- M2.1 For each monitoring/discharge point or utilisation area specified below (by a point number), the licensee must monitor (by sampling and obtaining results by analysis) the concentration of each pollutant specified in Column 1. The licensee must use the sampling method, units of measure, and sample at the frequency, specified opposite in the other columns:
- M2.2 Water and/ or Land Monitoring Requirements

For the purposes of this licence, "*Special Method 1*" means that samples must be tested for the active constituents contained within all the pesticide products applied within the last 3 months to the effluent utilisation area/s of the reuse farm associated with each sampling event.

M2.4 For the purposes of the table(s) above, monitoring at points 9, 10, 14, 71, 72, 73, 74, 75, 76, 77, 78, 79, 80,

81, 82, 83, 87 and 88 is not required when the bore is dry or inadequate water is available to collect a sample.

M2.5 For the purposes of the table(s) above, monitoring at points 24, 26, 28, 30, 32, 34 and 36 is not required if there are no discharge events for the that monthly period or there is inadequate water available to collect samples.

M3 Testing methods - concentration limits

M3.1 Subject to any express provision to the contrary in this licence, monitoring for the concentration of a pollutant discharged to waters or applied to a utilisation area must be done in accordance with the Approved Methods Publication unless another method has been approved by the EPA in writing before any tests are conducted.

M4 Testing methods - load limits

Note: Division 4 of the *Protection of the Environment Operations (General) Regulation 2022* requires that monitoring of actual loads of assessable pollutants listed in L2.2 must be carried out in accordance with the relevant load calculation protocol set out for the fee-based activity classification listed in the Administrative Conditions of this licence.

M5 Weather monitoring

M5.1 For each monitoring point specified in the table below, the licensee must monitor (by sampling and obtaining results by analysis where necessary) the parameters specified in Column 1. The licensee must use the sampling method, units of measure, averaging period and sample at the frequency specified opposite in the other columns.

M5.2 For the purposes of this condition, "Special Method 2" means that the licensee must install a permanent meteorological monitoring station and logger. The location of the site chosen for the station and details of equipment, measurement and maintenance/service procedures and schedules to be installed or implemented and maintained must be submitted in writing to the EPA and approved in writing by the EPA before any sampling or analysis is carried out. The meteorological station must be calibrated at least once every 12 months. The EPA is to be provided with data on request in a Microsoft ® Office software compatible format.

M6 Recording of pollution complaints

- M6.1 The licensee must keep a legible record of all complaints made to the licensee or any employee or agent of the licensee in relation to pollution arising from any activity to which this licence applies.
- M6.2 The record must include details of the following:
 - a) the date and time of the complaint;
 - b) the method by which the complaint was made;

c) any personal details of the complainant which were provided by the complainant or, if no such details were provided, a note to that effect;

d) the nature of the complaint;

e) the action taken by the licensee in relation to the complaint, including any follow-up contact with the complainant; and

f) if no action was taken by the licensee, the reasons why no action was taken.

- M6.3 The record of a complaint must be kept for at least 4 years after the complaint was made.
- M6.4 The record must be produced to any authorised officer of the EPA who asks to see them.

M7 Telephone complaints line

- M7.1 The licensee must operate during its operating hours a telephone complaints line for the purpose of receiving any complaints from members of the public in relation to activities conducted at the premises or by the vehicle or mobile plant, unless otherwise specified in the licence.
- M7.2 The licensee must notify the public of the complaints line telephone number and the fact that it is a complaints line so that the impacted community knows how to make a complaint.
- M7.3 The preceding two conditions do not apply until 3 months after: the date of the issue of this licence.
- M7.4 For the purpose of condition M7.1, operating hours are defined as twenty-four hours a day, seven days a week.

M7.5 The public notification referred to in condition M7.2 must include specific reference to the fact that the complaints line may be used by the community for the reporting of overflows.

M8 Requirement to monitor volume or mass

- M8.1 For each discharge point or utilisation area specified below, the licensee must monitor:
 - a) the volume of liquids discharged to water or applied to the area;
 - b) the mass of solids applied to the area;
 - c) the mass of pollutants emitted to the air;
 - at the frequency and using the method and units of measure, specified below.

- M8.2 For the purposes of this licence, "*Special Frequency 3*" means that sampling must occur continuously for every irrigation (discharge to effluent utilisation area/s) event.
- M8.3 Equipment used to monitor the volume must provide data that is within 5 percent of the actual volume over the likely full range of flow required to be measured by the equipment.
- M8.4 In the event that the licensee cannot comply with a volume monitoring method as required by this licence solely due to the failure or malfunction of essential monitoring equipment, volume may be estimated using another agreed method approved in writing by the EPA. This provision only applies for the duration of the failure or malfunction. The licensee is to rectify the failure or malfunction as soon as practicable.
- M8.5 The licensee must:

a) submit in writing to the EPA a proposal for a method of volume estimation; or

b) use a method of volume estimation already approved in writing by the EPA,

to be used in the event that essential monitoring equipment referred to in the previous condition has failed or malfunctioned.

M9 Requirement to record bypass incidents from sewage treatment plants

M9.1 The licensee must record the following details in respect of each bypass of any of the appropriate treatment processes required by condition O3 which may be reasonably expected to adversely affect the quality of the final discharge:

a) the EPA point identification number through which the bypass discharged;

- b) the date, estimated start time and estimated duration of the bypass;
- c) the estimated volume of the bypass;
- d) the level of treatment of the sewage at the STP prior to discharge;
- e) the probable cause of the bypass;
- f) any actions taken to stop the bypass happening; and
- g) any actions taken to prevent the bypass happening again.
- M9.2 In addition to the details listed in the previous condition, the licensee must also record classification as a wet or dry weather bypass in respect of each bypass referred to in the previous condition. A dry weather bypass is a bypass that occurs when the flow rate of sewage at the inflow volume monitoring point of the STP does not exceed 180 L/s and a wet weather bypass occurs when this flow is equalled or exceeded at any time during the bypass event.
- M9.3 From October 2003 the licensee must record the following details in relation to each observed or reported overflow from the reticulation system and from the sewage treatment plant:
 - a) the location of the overflow;
 - b) the date, estimated start time and estimated duration of the overflow;
 - c) the estimated volume of the overflow;
 - d) a description of the receiving environment of the overflow;
 - e) classification as a dry or wet weather overflow;
 - f) the probable cause of the overflow;
 - g) any actions taken to stop the overflow happening;
 - h) any actions taken to clean up the overflow; and
 - i) any actions taken to prevent the overflow happening again.

M10 Other monitoring and recording conditions

- M10.1 Biosolids at the premises must be recorded, monitored and classified in accordance with the Biosolids Guidelines, to the extent that those Guidelines are applicable, or as otherwise approved in writing by the EPA.
- Note: This condition does not apply to the reuse or disposal of biosolids by the licensee at locations other than the premises.

6 Reporting Conditions

R1 Annual return documents

- R1.1 The licensee must complete and supply to the EPA an Annual Return in the approved form comprising:
 - 1. a Statement of Compliance,
 - 2. a Monitoring and Complaints Summary,
 - 3. a Statement of Compliance Licence Conditions,
 - 4. a Statement of Compliance Load based Fee,
 - 5. a Statement of Compliance Requirement to Prepare Pollution Incident Response Management Plan,
 - 6. a Statement of Compliance Requirement to Publish Pollution Monitoring Data; and
 - 7. a Statement of Compliance Environmental Management Systems and Practices.

At the end of each reporting period, the EPA will provide to the licensee notification that the Annual Return is due.

- R1.2 An Annual Return must be prepared in respect of each reporting period, except as provided below.
- R1.3 Where this licence is transferred from the licensee to a new licensee:

a) the transferring licensee must prepare an Annual Return for the period commencing on the first day of the reporting period and ending on the date the application for the transfer of the licence to the new licensee is granted; and

b) the new licensee must prepare an Annual Return for the period commencing on the date the application for the transfer of the licence is granted and ending on the last day of the reporting period.

R1.4 Where this licence is surrendered by the licensee or revoked by the EPA or Minister, the licensee must prepare an Annual Return in respect of the period commencing on the first day of the reporting period and ending on:

a) in relation to the surrender of a licence - the date when notice in writing of approval of the surrender is given; or

b) in relation to the revocation of the licence - the date from which notice revoking the licence operates.

- R1.5 The Annual Return for the reporting period must be supplied to the EPA via eConnect *EPA* or by registered post not later than 60 days after the end of each reporting period or in the case of a transferring licence not later than 60 days after the date the transfer was granted (the 'due date').
- R1.6 Where the licensee is unable to complete a part of the Annual Return by the due date because the licensee was unable to calculate the actual load of a pollutant due to circumstances beyond the licensee's control, the licensee must notify the EPA in writing as soon as practicable, and in any event not later than the due date. The notification must specify:

a) the assessable pollutants for which the actual load could not be calculated; and

b) the relevant circumstances that were beyond the control of the licensee.

- R1.7 The licensee must retain a copy of the Annual Return supplied to the EPA for a period of at least 4 years after the Annual Return was due to be supplied to the EPA.
- R1.8 Within the Annual Return, the Statements of Compliance must be certified and the Monitoring and Complaints Summary must be signed by:

a) the licence holder; or

- b) by a person approved in writing by the EPA to sign on behalf of the licence holder.
- Note: The term "reporting period" is defined in the dictionary at the end of this licence. Do not complete the Annual Return until after the end of the reporting period.
- Note: An application to transfer a licence must be made in the approved form for this purpose.

R2 Notification of environmental harm

R2.1 Notifications must be made by telephoning the Environment Line service on 131 555.

- R2.2 The licensee must provide written details of the notification to the EPA within 7 days of the date on which they became aware of the incident.
- Note: The licensee or its employees must notify all relevant authorities of incidents causing or threatening material harm to the environment immediately after the person becomes aware of the incident in accordance with the requirements of Part 5.7 of the Act.

R3 Written report

R3.1 Where an authorised officer of the EPA suspects on reasonable grounds that:

a) where this licence applies to premises, an event has occurred at the premises; or

b) where this licence applies to vehicles or mobile plant, an event has occurred in connection with the carrying out of the activities authorised by this licence,

and the event has caused, is causing or is likely to cause material harm to the environment (whether the harm occurs on or off premises to which the licence applies), the authorised officer may request a written report of the event.

- R3.2 The licensee must make all reasonable inquiries in relation to the event and supply the report to the EPA within such time as may be specified in the request.
- R3.3 The request may require a report which includes any or all of the following information:

a) the cause, time and duration of the event;

b) the type, volume and concentration of every pollutant discharged as a result of the event;

c) the name, address and business hours telephone number of employees or agents of the licensee, or a specified class of them, who witnessed the event;

d) the name, address and business hours telephone number of every other person (of whom the licensee is aware) who witnessed the event, unless the licensee has been unable to obtain that information after making reasonable effort;

e) action taken by the licensee in relation to the event, including any follow-up contact with any complainants;f) details of any measure taken or proposed to be taken to prevent or mitigate against a recurrence of such an event; and

g) any other relevant matters.

R3.4 The EPA may make a written request for further details in relation to any of the above matters if it is not satisfied with the report provided by the licensee. The licensee must provide such further details to the EPA within the time specified in the request.

R4 Other notifications

R4.1 Where either:

a) sewage or partially treated sewage is discharged from the premises as a result of a bypass of the sewage treatment plant, or:

b) an observed or reported overflow has occurred from the reticulation system, and overflow or bypass may pose a risk to public health, the licensee is to promptly give appropriate notification to any parties that are likely to be affected, including:

i) the potentially affected community;

ii) the Department of Health;

iii) all other parties as identified in the Incident Notification Protocol.

R5 Annual system performance report

- R5.1 The licensee must supply to the EPA an Annual System Performance Report not later than 60 days after the end of each reporting period.
- R5.2 The report is to supplement the Annual Return and must include but need not be limited to:

(a) the 50 percentile, 90 percentile, 100 percentile and 3DGM values calculated from the monitoring data required by this licence for the reporting period for each pollutant which has corresponding concentration limits specified in this licence;

(b) the total amounts of biosolids, as classified in the Biosolids Guideline, disposed of on-site, offsite and to landfill during the reporting period;

(c) a diagram showing the major process elements, discharge points and monitoring points at the premises' sewage treatment plant(s), where there has been any significant change since the previous reporting period or this information has not been provided previously to the EPA;

(d) an analysis and interpretation of all monitoring results, including all additional non-licence monitoring committed to in the site Operational Environmental Management Plan (OEMP) and actions to correct identified adverse trends;

(e) the number of dry and wet weather bypasses recorded over the reporting period (recorded in accordance with condition M9);

(f) a breakdown of the total number of complaints received by the licensee during the reporting period in relation to the premises into categories of "odours – sewage treatment plant", "odours – reticulation system", "water pollution – sewage treatment plant", "water pollution – reticulation system" and any other category indicated by the complaints;

(g) a summary of observed, reported or recorded wet weather overflows and observed, reported or recorded dry weather overflows and sewage treatment plant bypasses. These data are to be for the current reporting period and for the four previous twelve-month periods, for which data has been collected. Any significant actions taken to address bypasses or overflows are to be noted; and

(h) the amount of rainfall measured at a rain gauge at the STP, or at the rain gauge closest to the centre of the catchment of the sewage treatment system, for each month of the reporting period.

- R5.3 The Annual System Performance Report must be presented in a format approved in writing by the EPA.
- R5.4 The requirements of R5.2 (d), (e), (f) and (g) apply to the part of the reporting period beginning three months after the date the licence is varied to include this condition.

R6 Other reporting conditions

R6.1 When the licensee notifies the Department of Health or Safe Food NSW Shellfish Quality Assurance Program of a bypass or overflow incident, the licensee must also notify the EPA by telephoning its Pollution Line service on 131 555. Notifications are to be given as soon as practicable after the licensee or one of the licensee's employees or agents becomes aware of the incident, and must include all relevant information including the information required under condition M9.1 or M8.1.

7 General Conditions

G1 Copy of licence kept at the premises or plant

- G1.1 A copy of this licence must be kept at the premises to which the licence applies.
- G1.2 The licence must be produced to any authorised officer of the EPA who asks to see it.
- G1.3 The licence must be available for inspection by any employee or agent of the licensee working at the premises.
- Note: For the purposes of this condition, "the premises" refers to each Sewage Treatment Plant(s) described in condition A2.1.

G2 Contact number for incidents and responsible employees

G2.1 The licensee must operate 24-hour telephone contact lines for the purpose of enabling the EPA to directly contact one or more representatives of the licensee who can:

a) respond at all times to incidents relating to the premises; and

b) contact the licensee's senior employees or agents authorised at all times to:

i) speak on behalf of the licensee; and

ii) provide any information or document required under this licence.

G2.2 The licensee is to inform the EPA in writing of the appointment of any subsequent contact persons, or changes to the person's contact details as soon as practicable and in any event within fourteen days of the appointment or change.

G3 Signage

G3.1 The location of EPA point number(s) 8 to 10, 14, 19, 20, 22 to 36, 45 and 71 to 88 must be clearly marked by signs that indicate the point identification number used in this licence and be located as close as practical to the point.

G4 Other general conditions

G4.1 The licensee must prepare, implement and maintain a current Operations Environmental Management Plan (OEMP) that addresses each of the key sites associated with the Licence including the treatment plant, sewage pumping stations, pipelines and the irrigation system in consultation with the EPA.

The OEMP must address (but is not limited to) the issues listed in condition 22 of the Parry Shire Council Notice of Determination for Development Application 2000/264 dated 22/08/2002.

To ensure that the OEMP remains current and up to date, it must be reviewed a minimum of once every two years. The EPA must be consulted with respect to any amendments to the OEMP proposed following each review.

G4.2 The licensee must establish and maintain a community environment liaison committee, comprising

representatives of the community, the licensee and other appropriate stakeholders that will meet at least once per year. Discussion at the meetings must include implementation of the development consent and other statutory approvals and provide time for the community to review monitoring records and raise matters of concern associated with the environmental impact of the development, with a view to achieving mutually satisfactory solutions.

Note: Where the licensee can demonstrate that community representatives are not participating in community environment liaison committee meetings and that concerns raised at previous committee meetings have been adequately addressed, the EPA may consider reducing the frequency of required committee meetings, or removing this condition from the premises Environment Protection Licence.

8 Special Conditions

E1 Management of Contaminated Biosolids

E1.1 All works and management actions conducted within the 'Environmental Management Area' as identified on the map entitled 'Swan Street Pumping Station, Area under Environmental Management', prepared by the licensee, dated 30/05/2018 (EPA Reference: DOC18/427279) must be conducted in accordance with the document entitled 'Swan Street - Biosolids Stockpile, Long Term Management Plan', prepared by GHD, dated October 2016 (EPA Reference: DOC18/42729).
